Joint UNECE / Eurostat Workshop on Implementing the Common Statistical Production Architecture Wiesbaden, Germany, 3-5 July 2017

INFORMATION NOTICE No. 11

I. Introduction

- 1. The workshop will be held in Wiesbaden, Germany at the premises of DESTATIS, the German Federal Statistical Office, from 3-5 July 2017, back to back with a workshop of the European Commission ESSNet project on Sharing Common Functionalities in the ESS² (6-7 July 2017). It is being organised in the context of the work of the High-Level Group on the Modernisation of Official Statistics³. It aims to promote the use of the Common Statistical Production Architecture (CSPA), to facilitate the sharing of ideas and plans for modernising statistical production, and to identify opportunities for international collaboration activities.
- 2. A key challenge facing managers, IT professionals, architects and methodologists in national and international statistical organisations is how to implement new tools and standards that facilitate sharing and re-use across statistical domains and between statistical organisations. The CSPA has been developed to support this trend, and provide a blue-print for a new way of designing, building and implementing the tools needed to produce official statistics. It has been adopted as the basis for the European Statistical System SERV projects, which aim to develop common services as part of the Vision 2020 initiative.
- 3. The workshop is primarily intended for staff of statistical organisations who are responsible for developing and implementing corporate IT solutions, as well as methodologists working on cross-domain solutions, enterprise and information architects, and subject-matter specialists involved in the modernisation of statistical production.

II. Agenda of the workshop

- 4. The workshop will have an interactive format, and will include the following themes:
 - What is the CSPA, and what does it mean for my organisation? This theme will have a training and capacity-building focus, to ensure participants have a basic understanding of the CSPA and its benefits.
 - How to implement the CSPA: Under this theme, participants are encouraged to present practical case studies showing challenges, successes and lessons learned
 - What does the CSPA mean for different groups of staff? Participants will be split into groups based on the role they play in their organisation (IT professionals, architects, methodologists and subject-matter specialists) to discuss how CSPA implementation will affect their work
 - Overcoming the barriers: How to accelerate CSPA implementation? This theme will focus on how to improve the support to CSPA implementers by identifying any barriers to implementation, and how to remove them.
 - How to communicate about the CSPA?

Participants representing non-governmental organisations in a consultative status with the United Nations Economic and Social Council may also attend. **All participants must be accredited by the competent authorities of their country or international organisation.** All participants attending the workshop are requested to have a valid passport and, if required, a visa. Applications for visas to Germany should be made as soon as possible (to the German Embassy) in the country where the participant resides, with a reference to the Joint UNECE / Eurostat Workshop on Implementing the Common Statistical Production Architecture.
- 6. Statistical organisations are asked to confirm **before 28 February 2017** whether their organisation intends to participate at the workshop. Please inform the UNECE secretariat (marlen.jigitekov@unece.org).
- 7. Participants are requested to fill in an electronic registration form, via the website indicated in paragraph 10, by 31 March 2017.

IV. Documentation, methods of work and official languages

- 8. The official language of the workshop is English. Any contributions should, therefore, be submitted in English only. Contributions can include case studies, papers, presentations, demonstrations and videos. Other forms of contribution can be proposed. The following deadlines and requirements apply:
 - Any organisations wishing to submit a contribution to the workshop, are requested to send
 a short abstract, as well as author name(s) and contact details, to the UNECE secretariat
 (marlen.jigitekov@unece.org) as soon as possible and by 28 February 2017 at the latest.
 - Contributions should be sent to the UNECE secretariat (marlen.jigitekov@unece.org) by 31 May 2017. Any papers should be submitted in electronic format in MS Word, and should not exceed 10 pages in length.
- 9. On the basis of the contributions received, the Organising Committee will decide which of them will be allotted time for presentation. Please note that due to the nature of the workshop, **only a limited number of contributions will be presented**, others will be used as background information for the discussions.
